

COOKIES USAGE POLICY

(the edition is valid from 27.05.2024)

This Cookies Usage Policy (hereinafter referred to as the "Policy") is created to explain to Users how the Website uses cookies and similar technologies to help Users understand their options for managing cookies.

The terms in this Policy are used in accordance with the User Agreement (Terms of Use), the Anti-Money Laundering and Counter-Terrorist Financing Policy, the Privacy Policy, and the relevant legislation on data protection of information, texts, and other products offered by the Company.

• **WHAT ARE COOKIES?**

- The Website may use "cookies", which are small text files placed on the User's computer or device. The Website uses pixel tags, web beacons and other similar technologies. These devices are used to analyze the web flow of pages, customize the services of the Website, optimize user interfaces, measure advertising effectiveness and build trust and security.

- Cookies are small text files that websites store on your computer or mobile device when you visit the site.

- Cookies can be eternal and stored in the computer until the User deletes them, or temporary (such cookies are called session cookies), i.e. they are stored only until the browser is closed. In addition, cookies are divided into first-party and third-party cookies, in addition, we draw the User's attention to the fact that:

- when the user visits the Website again, the cookie data is updated;
 - in most cases, the web browser allows automatic storage of cookies on the user's device by default;

- disabling cookies may result in restriction of access to published materials and/or inadequate functioning of the Website services.

- When visiting the Website, the User is given the opportunity to accept the cookies used on the Website, accept and reject certain categories of cookies or reject all cookies. If the User has agreed to the use of some or all cookies by the Website, the following information applies only to the cookies used on the Website.

• **TYPES OF COOKIES USED ON THE WEBSITE**

- According to the classification of the International Chamber of Commerce, the Website Administration may use the following categories of cookies:

- Strictly necessary cookies are required for the user to move around the Website and use certain services, for example, to access secure pages, register and authorize, search the Website. Also, they memorize the previous actions of the User when going to the previous page in the same session.

- Performance cookies aggregate information about how the Website is used. This data is stored on the user's device between web browser sessions. All information collected through performance cookies is intended for statistical and analytical purposes. Some cookie data may be provided to third parties who have permission from the Website and solely for the purposes specified above.

- Functional cookies are used to save parameters or configurations that are stored on the User's device between web browser sessions. These cookies also allow users to watch videos, participate in interactive activities (polls, voting) and interact with social networks. To make the experience more pleasant after visiting the resource, these cookies remember the information provided by the User, increasing the efficiency of interaction with the Site.

- Targeted cookies are used to provide content that may be of interest to the User. This data is stored on the User's device between web browser sessions..

- The Website Administration may provide information about cookies to third parties, including but not limited to media clients, advertisers, agencies and partners.
- For prompt delivery, better display and detailed analysis of the content on the Website, the Website Administration uses services owned by other third-party companies, such as Facebook, Twitter, Instagram, and others. These companies may use cookies on the User's device while working on the Website.

• **MANAGEMENT OF COOKIES**

- The User has the right to choose whether to accept cookies.
- If the User decides to refuse cookies, he/she will not be able to use the full functionality of the Website
 - The User can change the settings on the cookie policy page at any time.
 - As an alternative, the User can block all cookies by activating the settings in his/her browser (see the help of his/her browser to find out how to do this), which allow you to refuse to set all or some cookies.
 - If the User uses the settings of his browser to block all cookies (including essential cookies), he will not be able to access all or some parts of our Website.
 - If the User accepts some or all of the cookies on this Website, they can still configure their browser so that the browser notifies the User when they receive a cookie and so that they can determine whether to accept it or not.
 - Disabling cookies will affect the functionality of this and many other websites that the User visits. Disabling cookies usually leads to the disabling of certain functionalities and features of this Website. Therefore, it is recommended not to disable cookies.

• **WHAT DATA IS COLLECTED**

- The Website automatically collects certain personal data from the User's device when he/she visits this Website, for example:
 - IP-address.
 - The requested domain name.
 - The name of the Internet Service Provider (ISP) is sometimes written depending on the configuration of the Internet service provider.
 - Date and time of visit to the website.
 - Session duration.
 - Pages that were accessed.
 - How many times the Website was visited during the month.
 - The URL of the file you are viewing and information related to it.
 - The website from which you came to our Website.
 - The operating system your computer uses.
 - Collecting this information allows us to better understand the visitors who come to the Website, where they come from and what content on our Website interests them. The Website uses this information for internal analytics purposes and to improve the quality and relevance of our website for visitors. Information will be collected using cookies and similar tracking technologies.
